


# **Typical Inductance vs. Current Characteristics:**




## **Typical Temperature Rise vs. Current Characteristics:**




Airflow testing was done with 115mm Ø fan and air velocity was measured directly in front of the part between the fan and part.







#### Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.

#### Pottina:
